## HISTORY OF NWC AND NWCF

---

The Northbrook Woman's Club (NWC) and the Northbrook Woman's Club Foundation (NWCF) of today was founded as the Northbrook Junior Woman's Club on October 5, 1955 by six young women who attracted 18 others by placing an ad in the local newspaper. The first monthly meeting place was at the old medical center on Shermer Road. The club was first conceived as a service organization as it is today. Early projects were staffing the library story hour, the offices for Northbrook Community Nurses, and the North Shore Mental Health Center. The members also attended meetings of the Village Board, the Library Board, the Planning Commission, the Park Board, local school boards, and the Safety Commission. By their interest and participation, our members played an important role in shaping the community of Northbrook as we know it today.

Michigan Shores Country Club hosted the first benefit in March 1956, with a profit of \$251, followed in the fall with a dinner dance making \$603. A Bonwit Teller fashion show brought in an additional \$452. In 1963, the club started its own scholarship fund, which continues to be our largest philanthropic contribution to date with a total of \$816,814 supported by various Ways & Means endeavors such as the annual Benefit, corporate donations, cookbook sales, holiday boutiques, and raffle ticket sales. In addition, NWC and NWCF have made significant financial contributions to various organizations and projects in the metropolitan area such as Youth Services of Northbrook/Glenview, Family Service Center, Hunger Resource Network, Special Gifts Theatre, and YWCA Evanston/North Shore. The total of these contributions to date is \$671,889.

Since the club's founding more than 65 years ago, Northbrook has grown from 3,300 residents to over 35,000 residents, and the club has grown from 24 members to 152 members with active, new, sustaining, or honorary status. Each member is dedicated to preserving our mission:

## NWCF WAYS AND MEANS

---

### Membership Financial Obligation

The Foundation Bylaws, Article III, Section 2, state that each active member shall annually support, both actively and financially, the NWCF Ways and Means efforts. Each active or new member for 2024-2025 shall fulfill the financial obligation in the following ways:

- (1) All active members are required to buy or sell 7 raffle tickets @ \$5 each for a total of \$35. The required raffle ticket purchase for active members must be completed during the membership renewal process, no later than July 31<sup>st</sup>, 2024.
- (2) All active members are required to pay a separate \$300 Ways & Means Obligation by September 25, 2024. This obligation includes a \$135 tax-deductible donation to the Foundation AND one ticket each to three Social events (Ladies Night Out, Holiday Luncheon, and Members Only Luncheon).

If an active member is unable to attend a Social event, their ticket will convert to a \$55 tax-deductible donation to the Foundation. All Foundation proceeds in the 2024-2025 fiscal year will benefit Grants and Scholarships.

The total Ways and Means financial obligation per active member for the 2024-2025 Foundation year is \$335. A \$20 late fee may be invoiced if either payment is received after the due date.

Note: If you determine that you can no longer attend a social event after registering for your ticket, you can still convert this to the \$55 donation value if notification is given by the event RSVP deadline. If notification is given after the deadline, you are encouraged to give your ticket to a friend.

### Raffle

All members will receive an annual Yearbook and other pertinent information regarding events / activities electronically. Physical copies can be picked up at the Fall general meetings and/or will be delivered to Sustainers, Honorary, and New members. Raffle tickets not purchased during the membership renewal process are available to purchase online or by mail. Active members are encouraged to purchase additional raffle tickets. Sustainers and Honorary members are also encouraged to purchase raffle tickets. Drawings will be held monthly September through May and announced at each general meeting or luncheon. If a meeting or luncheon does not occur within a calendar month, the tickets will be drawn virtually and the winners announced in the newsletters. At each drawing, two raffle tickets will be randomly selected with the first ticket's owner winning \$50 and the second winning ticket's owner winning \$100.
